

## **Global Privacy Policy for Customers – Japan Annex**

Last Updated: 5 October, 2022

Effective Date: 5 October, 2022

This Japan Annex will be applied if the following Glico group companies process your personal data.

- [Other Glico group companies located in Japan](#)
- Among [Glico group companies located outside Japan](#), a company which handles the personal data of Customers in Japan in relation to providing goods or services to them

The provisions of each Section described below are supplementary to the provisions of the respective Sections with the same numbers and same titles of the Global Privacy Policy unless otherwise specifically stipulated in such Section below.

### **2. Purposes of the Group's Use of Your Personal Data**

#### **(1) Adjustment of "Personal Data" definition from the Japan laws standpoint**

In the relationship with Customers to whom this Japan Annex is applied, each term “personal data” used in Section 1. and Section 2. of the Global Privacy Policy shall be changed to read “personal data” as “personal information” as defined in the Act on the Protection of Personal Information of Japan (the “Act”).

Meanwhile, “personal data” used anywhere, except in Section 1 and Section 2, in the Global Privacy Policy and this Japan Annex means “personal data” as defined in the Act.

#### **(2) Obtaining of Your Browsing History etc.**

The Group may obtain, from a data management platform managed by a third party, your web browsing history collected by Cookies and the analysis results thereof, and may use the same for the purposes stated in Section 2 of the Global Privacy Policy by connecting or linking such results to your personal data.

### **3. How the Group Shares Your Personal Data**

The Group may share your personal data with any third party only in the case stated in **Section 3. “How the Group Shares Your Personal Data”** of the Global Privacy Policy.

In sharing personal data with other Glico group companies in Japan, the Group conducts such sharing as

“joint utilization” defined in the Act to the extent as follows.

- (1) The subject of joint utilization is personal data stated in **Section 1. “Categories of Personal Data the Group Collects”** of the Global Privacy Policy
- (2) Shared personal data is jointly utilized by [Glico group companies located in Japan](#).
- (3) Purposes of use in joint utilization are those stated in **Section 2. “Purposes of the Group’s Use of Your Personal Data”** of the Global Privacy Policy.
- (4) Ezaki Glico Co., Ltd, is fully responsible for managing personal data jointly utilized.

With your consent to the Global Privacy Policy and this Japan Annex, the Group may share personal data stated in **Section 1. - The Glico group companies receiving personal data for the abovementioned sharing purpose will comply with laws and regulations on personal information protection in the respective countries and territories where the Glico group companies are located.

## **7. Customers’ Rights**

Notwithstanding the provisions of **Section 7. Customers’ Rights** of the Global Privacy Policy, the following provisions will be applied.

You or a person acting on your behalf may, in accordance with procedures prescribed by the Group, request the Group to (i) disclose to you its retained personal data (as defined in the Act) that identify you,

(ii) correct, add or delete the contents of such personal data, (iii) cease the use of, delete, or cease the provision to any third party of, such personal data (iv) inform you of the purpose of use of such personal data, or (v) disclose the record of provision of personal data to any third party.
