

Global Privacy Policy for Customers – PRC Annex

- [Glico group companies located outside the People’s Republic of China](#) (the “PRC”, for the purpose of this Annex, excluding the Hong Kong Special Administrative Region, the Macau Special Administrative Region and Taiwan) which directly collects personal data of customers who reside in PRC

The provisions of each Section described below are supplementary to the provisions of the respective Sections with the same numbers and same titles of the Global Privacy Policy unless otherwise specifically stipulated in such Section below.

1. Categories of Personal Data We Collect

You agree to the collection of your **Personal Sensitive Data** defined under the Personal Information Protection Law and the Personal Information Security Specification (GB/T 35273-2020), including but not limited to the information of bank account, credit card, transaction and consumption records, which are necessary and required for our supply or delivery of goods or services to you. If you refuse to provide such Personal Sensitive Data to us, it may bring results that we fail to supply or deliver our goods or services to you or the goods or services you will receive from us are restricted

3. How the Group Shares Your Personal Data

You agree that your personal data may be entrusted to be processed, shared, transferred or disclosed by us to other Glico group companies and third parties, including but not limited to distributors, retailers, agencies, services providers, sub-contractors, suppliers, professional advisors and any necessary third parties as described in **Section 3 “How the Group Shares Your Personal Data”** of the Global Privacy Policy. The above entrusted processing, share, transfer and disclosure of your personal data will be conducted in compliance with laws and regulations of the PRC and other applicable laws and regulations.

4. Data Transfer Outside of Country

You agree that we will give direct access to your personal data and/or transfer your personal data to Glico group companies outside the PRC, to the extent such access and/or transfer is necessary and required for the purpose of use stated in (a)(b)(i)(j) of **Section 3. “How the Group Shares Your Personal Data”** of the Global Privacy Policy, and provided that such access and/or transfer is made in compliance with laws and regulations of the PRC and other jurisdictions where your personal data is transferred to. 7. Customers’ Rights

You have the right to withdraw your consent for processing of your personal data as described in **Section 7 “Customers’ Rights”** of the Global Privacy Policy. However, please note that the withdrawal of your consent does not affect the lawfulness of any processing activities conducted by us based on such consent before your withdrawal. Please also note that, in case you choose to withdraw consent to our processing your personal data, we may not be able to provide certain services to you. In such case, we will not be liable and/or responsible for the suspension of certain services to you due to your withdrawal of consent.

12. Policy Changes

Notwithstanding the provisions of **Section 12 “Policy Changes”** of the Global Privacy Policy to the contrary, the following provisions will be applied.

We may change this PRC Annex from time to time and we will post the revised version on this site or page. We will provide more significant notice (including sending a notice via email specifying the detailed changes of this PRC Annex) to you for material changes of this PRC Annex. By continuing to use our products and/or services, you agree to be bound by this revised version of this PRC Annex.

13. Children
