

Global Privacy Policy for Customers – Taiwan Annex

This Taiwan Annex will be applied if the following Glico group companies process your personal data.

- Glico Taiwan Co., Ltd.
- [Glico group companies located outside the territory of Taiwan](#), China which directly or indirectly collect personal data of Customers residing or locating within the territory of Taiwan.

You may provide or not to provide relevant personal data at your own discretion. In case you decide not to provide the relevant personal data, we will not be able to provide service to you by our sole discretion.

The provisions of each Section described below are supplementary to the provisions of the respective Sections with the same numbers and same titles of the Global Privacy Policy unless otherwise specifically stipulated in such Section below.

2. Purposes of the Group’s Use of Your Personal Data

The collection or processing of personal data by us shall be for specific purposes and using personal data shall only within the necessary scope of the specific purpose of collection. The specified purposes are as set forth in **Section 2 “Purposes of the Group’s Use of Your Personal Data”** of the Global Privacy Policy.

The specified purposes of personal data can be categorized as follows pursuant to the “Specific Purpose and the Classification of Personal Data of the Personal Data Protection Act”:

- (a) Marketing (No. 040);
- (b) Membership management (No. 052);
- (c) Collection, processing or use of the personal data by non-government agency under its legal obligation (No. 063);
- (d) Contracts, its equivalent or other legal relationship matters (No. 069);
- (e) Consumer and customer management and service (No. 090);
- (f) Business and technology information (No. 098);
- (g) Information and communication services (No. 135);
- (h) Information and communication and database management (No. 136);
- (i) Information and communication security and management (No. 137);
- (j) Internet shopping and other electronic commerce services (No. 148);

- (k) Advertisements or business conduct management (No. 152);
- (l) Survey, statistic and research analysis (No. 157); and
- (m) Other businesses which meet the business registration item or specified in the charter (No. 181)

4. Data Transfer Outside of Country

We will never transfer your personal data outside of the territory of Taiwan to any receiver of international transmission who is restricted or prohibited by laws, regulations and the authorities of Taiwan.

7. Customers' Rights

You may exercise the following rights with respect to your personal data pursuant to Article 3 of the Taiwan Personal Data Protection Act 2015 and such rights shall not be waived or limited contractually in advance:

- (a) making enquiries or requesting to review your personal data;
- (b) requesting a copy of your personal data;
- (c) requesting to supplement or correct error with respect to your personal data;
- (d) demanding the cessation of the collection, processing or use of your personal data; and
- (e) demanding deletion with respect to your personal data held by us.
